Why does this matter? And why now?

- Armed conflicts are intensifying globally, from Gaza to Sudan to the DRC, putting civilians and critical infrastructure at growing risk.
- IHL remains the key framework for monitoring conduct, advocating for accountability, and protecting civilians.
- The complexity of the law, rising threats to its authority, persistent impunity, and double standards leave serious violations unaddressed.
- Credible, evidence-based reporting is essential to support accountability and justice. Journalists are often the first to expose abuses, trigger scrutiny, and support justice.
- To support the media, humanitarian actors, and other stakeholders in their key role in protecting civilians, the IHL Centre will launch the <u>Stockholm</u> <u>Manual</u> on 24 September 2025. The Manual is an innovative tool for monitoring IHL compliance and advocating stronger civilian protection.
- Journalists themselves face serious risks when reporting from conflict zones, and IHL provides them with specific protections as civilians. The Manual also offers guidance on how journalists and media organisations can advocate for these protections in practice.


